“Projects of life and skills development: Different approaches to valuing parenting in work and life”

For two years, public authorities, representatives of SMEs and the social economy, researchers as well as NGOs have been working on ways to facilitate work-life balance and (women) employment.

Among the results of the “Master Parenting in Work and Life” initiative, co-funded by the EaSI programme of the European Union, are a unique training programme for employees with care tasks, an online platform targeting specifically unemployed women, diverse actions mobilizing employers or a collection of best practices of cities/regions and (social economy) enterprises, to name just a few.

This work confirmed once again the importance of cooperation and coordination between different players (policy-makers, administration, enterprises, civil society, families...) and policies.
